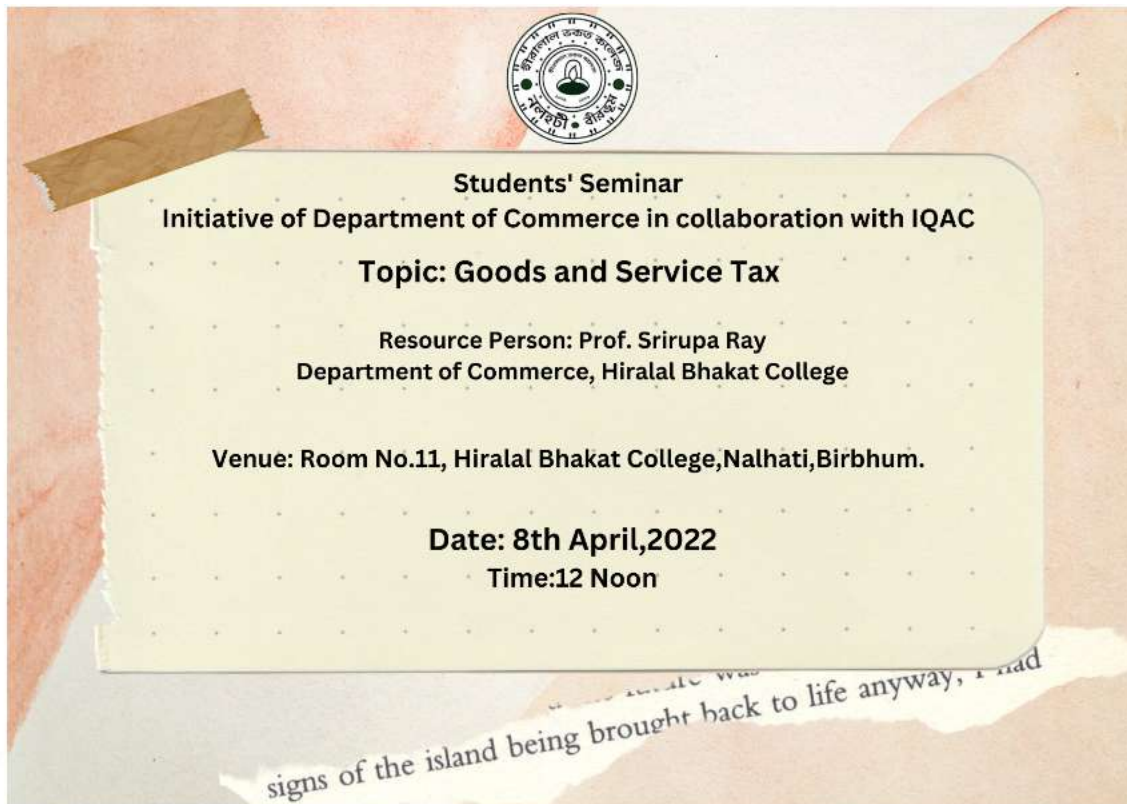








**Programme Details:**

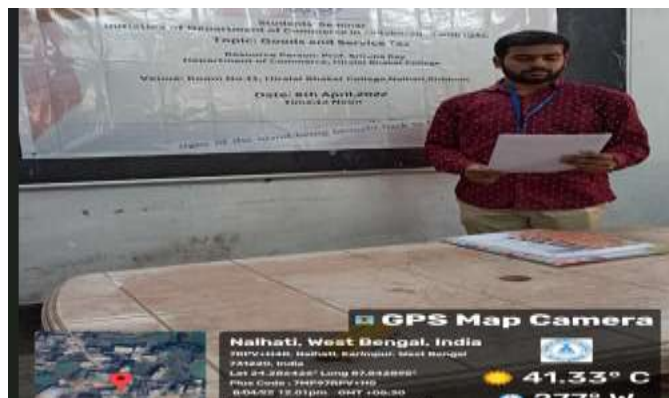

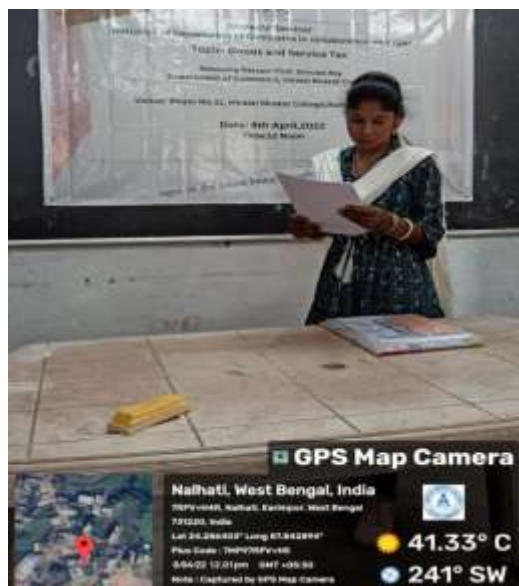
**Outcome**
